Response: The information on air quality parameters as sought by you is available in the public domain of SAFAR website on day to day basis (<http://safar.tropmet.res.in>) along with its forecast in the mail page as well as in the bottom icon in the home page- "location Specific Online Services" and "Air quality now & forecast". The SAFAR is a research forecasting project and whatever information is shareable is displayed in its website as per the data policy of the institute. The agency for other dissemination of data for air quality is state pollution control board and for weather data, it is IMD and you are request to approach them directly.

2. Please provide us with AQMS (Air Quality Monitoring System) specific data on different monitored pollutants (PM 10, PM 2.5, NO2, CO, O3 etc.) and respective AQI (Air Quality Index) data in the city of Mumbai location. Please provide information location wise and month wise separately.
