Please provide following information in respect of Tender No. IITM/Transport/2018/1, Event no. IITM/17-18/ET/101.

**Sr. No. 1 : Allotment status of Tender.**

**Reply –** Work order for providing Hiring services of taxi/tourist vehicles at Institute has been issued to M/s Jogeshwari Travels, Pune and M/s Executive Car Rental Services (ECRS), Pune after following due procedure.

**Sr. No. 2 : Details of rejected applications.**

**Reply –**

(1) M/s. M/s. Om Tours and Travel Pune has been technically disqualified in the technical evaluation. The gist of the report is as below;

(1) As per pre-bid minutes

**Point No. 7 : Clarification regarding Owned / Attached vehicle details required.**

**Reply:** The service agency must be having ownership of least 10 tourist vehicles (like Indica, Indigo, Swift desire etc.) in the firm's name / proprietor's name (RC copies has to be submitted along with technical bid).

M/s. Om Tours and Travel Pune has not submitted any details of the vehicle owned by them in the technical bid which is one of the qualifying criteria as stated above. Considering the same committee recommends disqualifying their bid as it is not meeting qualifying criteria.

(2) M/s. Sunny Travels, Pune has been not considered in the commercial evaluation. The gist of the report is as below;

The commercial bids of above three firms were opened. The committee noted that M/s. Sunny Travels, Pune has not uploaded the Price schedule (Chapter 5) on the Institute's e-procurement site as per the requirement. As their prices were not known hence the quotations of M/s. Sunny Travels, Pune has not been considered for commercial evaluation.
