# <u>Technical specifications for Non-Comprehensive Maintenance Contract of for</u> Workstations

Annexure - I

- 1. Preventive Maintenance of the workstations/servers will be carried out on quarterly basis.
- 2. No advance can be paid towards the maintenance charges.
- 3. Quarterly payment on completion of each quarter.
- 4. Vendor should have at least 5 years proven experience in the relevant field.
- 5. Maintenance service should be available from Monday to Friday from 9:30 to 18:00 Hrs. on some occasions such complaints to be attended non-working days/off duty hours or in emergency telephonically
- 6. Vendor should give SLA for 24X7 supports valid for 1 Year with 2 hours response time and same day's resolution.
- 7. The contract will be valid for a period of one year. Institute can terminate the AMC if not satisfactory. The contract may be terminated by either party by giving one month's notice in writing.
- 8. **Penalty Clause:** Penalty shall be imposed for not meeting the SLA i.e. if not responded within 2 hours at the rate of Rs. 500/- for delay of every 2 hours and maximum up to 5% of the total contract value.
- 9. Delay, if any beyond 30 days the maintenance contract would stand extended by the total number of days of delay without any additional charges.
- 10. The successful firm/contractor, within a period of 10 days, shall furnish a Bank Guarantee for 10% of the total cost of CAMC, valid till the end of the contract period towards security for smooth performance of the CAMC.
- 11. The cost of any pat required to be replaced will be communicated to the institute by the contractor in writing and will be replaced by him only after receiving approval from the appropriate authority. The replaced part will carry a warranty of at least six months from the date of replacement.
- 12. In case of additional accessories or devices are to be added to this configuration later, its installation /maintenance should be done free of cost.
