The EoI pre-submission meeting for the EoI tender (PS/125/16/2025/EOI) “Design, Development, Installation and Commissioning of the Cloud Chamber Research Facility and its Infrastructure at IITM, Pune as a Turnkey Job” was convened by the Purchase and Stores Section at Pisharoty Hall on October 09, 2025, from 1200 hrs in hybrid mode (online + offline).

Agenda for the meeting:

Discuss the queries / requests received from the interested participants as well as any other points brought up in the meeting.

Participants for the meeting:

Eight (08) companies/firms attended the meeting as per the attached sheet (Annexure I). Every participating company/firm was asked to briefly introduce themselves, outline their queries/requests along with the proposals to carry out the present project.

Queries/Requests by the Participants:

It was noted that there were no specific technical queries from any of the participants at this stage. Similarly, there were no specific queries with respect to the purchase-related aspects. A common request by all the companies/firms was to extend the deadline of submission of the EoI responses by time periods ranging from 2-3 weeks to 60-90 days. Some firms also requested additional pre-submission meetings. The queries/requests by the companies/firms are listed in Annexure I.

Recommendations by the Scientific and Technical Committee:

Based on the discussions in the meeting and the requests by the participating companies/firms, the Scientific and Technical Committee recommends the following:

1. The last date of receipt of EoIs at IITM may be revised to Thursday, 27 November 2025 i.e. an extension of one (01) month in the present deadline may be given.

2. All technical queries must be submitted to IITM in writing (over email) on or before Monday, 10 November 2025 by 1200 hrs.
3. A second EoI pre-submission meeting shall be conducted on Wednesday, 12 November 2025 to discuss the responses to the queries received.

The meeting ended with thanks to the Chair of the Scientific and Technical Committee, and all the members and participants.
