- 4. Payment terms will be as follows:

Equipment -

- i) 50% payment against delivery of the material (cables and all passive components.)
- ii) 40% after complete installation of the casing N capping, cabling and other related passive components.
- iii) 10% payment after furnishing Bank Guarantee from a Nationalized Bank for a period of one year.

Labour - 100% after complete installation of casing & capping, cabling and other related passive components. Payment will be made within 30 days after complete delivery of items and successful installation.

- 5. Quotations must clearly indicate the features offered unit price, sales tax, transport, octroi transit insurance, installation charges and any other charges. Institute cannot furnish any certificate for exemption or reduction in sales tax and octroi. However the Institute is exempted from payment of custom duty, central excise and exemption certificate will be issued on request before delivery of the goods.

Warranty

- 1. The supplier warrants that the goods supplied under the contract is new, unused and incorporate all recent improvements in design and materials unless prescribed otherwise by the purchaser in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopted and / or the material used are as per the purchaser's specifications) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India.
- 2. This warranty shall remain valid for twelve months after the goods or any portion thereof as the case may be, have been delivered to the final destination and installed at the final destination and accepted by the purchaser in terms of the contract or for twelve months from the date of complete installation. The supplier shall provide 1 year Passive Product Performance Warranty.
- 3. In case of any claim arising out of this warranty, the purchaser shall promptly notify the same in writing to the supplier.
- 4. Upon receipt of such notice, the supplier shall, with all reasonable speed, repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/goods after providing their replacements and no claim, whatsoever shall lie on the purchaser for such replaced parts/goods thereafter.
- 5. In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of the purchaser.
- 6. If the supplier, having been notified, fails to rectify/replace the defect(s) within a reasonable period, the purchaser may proceed to take such remedial action(s) as deemed fit by the purchaser, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which the purchaser may have against the supplier.
